

2019 Important Tax Information

Form 1099 changes in 2019

The Form 1099-B Box 12 has switched with Box 3. Box 12 now contains the checkbox to indicate the basis reported in Box 1e is being reported to the IRS. New Box 3 now contains checkboxes for Collectibles and Qualified Opportunity Fund (QOF) reporting. If reporting either investment type, the checkbox is used to indicate so. Form 1099-DIV Box 5 amount shows the portion of the amount in Box 1a that may be eligible for the 20% qualified business income deduction under section 199A.
