2020 Census Results Show Population Trends and Power Concentration in the U.S. Continue to Shift

- The 2020 Census results will have a significant amount of influence on political, financial, and public finance related outcomes for years.
- Overall, the population of the U.S. totaled about 331 million, according to the 2020 U.S. Census. State population growth exceeded 15% in Utah, Idaho, Texas, North Dakota, and Nevada. Only three states, Illinois, Mississippi, West Virginia, in addition to Puerto Rico, saw population losses.
- Political power is likely to continue to shift in the U.S. based on the 2020 Census results. This constitutional reapportionment could help the Republicans take back the House in the 2022 midterm elections. Texas gained two seats in the U.S. House of Representatives. Five states (Colorado, Florida, Montana, North Carolina and Oregon) each gained one seat in the House. Seven states (California, Illinois, Michigan, Pennsylvania, New York, Ohio, and West Virginia) each lost one seat in Washington.

2020 U.S. Census Results

This week, much attention is being placed on the Federal Reserve's meeting, corporate earnings, and especially President Biden's anticipated speech where he is expected to outline the American Families Plan and his overall economic agenda. However, on Monday the U.S. Census Bureau <u>released the first population count from the 2020 Census</u>.

Power Concentration Continues to Shift

If the concentration of power in the United States is where the people are, then the power is continuing to shift to the southeast, Texas, and to the western mountain states. Power continues to shift away from the northeast, midwest, and California. This population transfer resulted in Texas gaining two seats in Congress. Five states (Colorado, Florida, Montana, North Carolina and Oregon) each gained one seat. Seven states (California, Illinois, Michigan, Pennsylvania, New York, Ohio, and West Virginia) each lost one seat in Washington. In the near term, the results from this constitutional reapportionment could help the Republicans take back the House in the 2022 midterm elections.

This reapportionment and the results of redistricting could have a political impact for years. The results from the 2010 Census helped the Republicans. "Democrats have spent the last decade trying to climb out of the hole they found themselves in the last redistricting. After the 2010 midterm wave gave the GOP control of state governments, Republicans drew a new round of favorable maps in nearly all the key states," according to Politico.

Population Trends

The fastest-growing states reported were Utah, Idaho, and Texas. The slowest-growing states were Connecticut, Michigan, and Ohio. Only three states, Illinois, Mississippi, West Virginia, as well as Puerto Rico, saw negative migration.

Census Day-April 1, 2020

Census Day was April 1, 2020. Respondents told the Census Bureau where they lived as of April 1. Therefore, most COVID-19 related demographic changes are unlikely to be included in the 2020 Census results.

Next Step in the 2020 Census Timeline

The Census Bureau was charged with delivering population counts for apportionment to the president by April 30, 2021. This requirement was satisfied on Monday. The bureau is required to send redistricting counts to individual states by September 30, 2021 according to the <u>overall timeline</u>. The redistricting counts will be used to redesign legislative districts based on the 2020 Census population shifts.

Census Day was April 1, 2020. Respondents told the Census Bureau where they lived as of April 1. Therefore, most COVID-19 related demographic changes are unlikely to be included in the 2020 Census results.
