

## 2025 HilltopSecurities GFOA Conference Drawing (the "Promotion") Official Rules

- 1. Eligibility: The Promotion is open only to attendees of the 119<sup>th</sup> GFOA Annual Conference in Washington, D.C. Employees, contractors, directors and officers of Hilltop Securities Inc.
