



2026 HilltopSecurities Conference Drawing (the “Promotion”) Official Rules

1. **Eligibility:** The Promotion is open only to attendees of the 2026 Florida GFOA Annual Conference, 2026 Massachusetts Collectors and Treasures Association Annual Conference, and 120th GFOA Annual Conference in Chicago.
